# **SECRETARY'S REPORT:**

1) The Storytime program that was approved for Wednesday mornings at Station #2 will start on July 12<sup>th</sup>. SecretaryKrause will meet the 2 contacts at the station for key fobs and tour.

# **BOARD OF DIRECTORS:**

- 1) President Collins presented updates on the membership for the following Firefighters:
  - a) Joshua Snyde; He is currently on a "cooling off" status. His resignation request will be reviewed at the July meeting
  - b) Samantha Vick resigned from being a firefighter and Secretary for Station #2 as she has moved. Her resignation status is pending the July meeting.
  - c) Sara Bashant resigned as well. The Board of Directors will finalize her status in their July meeting.
  - d) An approved Request for Transfer of Active Membership from Company #2 to Company #1 was submitted for Jeremy Benassi.
- 2) The Board of Directors is currently reviewing the Social Room Policy and the Zero Tolerance policy.

#### **OLD BUSINESS:**

- 1) Although the Building Use Request for the Block Party at Station #2 in July was approved by the Board of Fire Commissioners, they are waiting for additional feedback from our insurance agent Greg Turner regarding the presence of alcohol
- 2) Our Pierce Communications contact was not present for an update on Public Outreach for our building project, but has offered another meeting on June 21st
- 3) A signed contract for the land purchase on Route 9W is with Attorney T. Hannigan. A land surveyor will be starting this week and could take up to five weeks to complete.

#### **NEW BUSINESS:**

- 1) Regarding the inclusion of information on our building project in the Town of Bethlehem Newsletter, Commissioner Van Apeldoorn will assist Pierce Communications if needed.
- 2) Chairman Wickham asked Chief Michaniw about creating lesson plans for firefighter training. Chief Michaniw will look into and offer feedback.

#### **COMMISSIONER REPORTS:**

#### 1) Commissioner Burns:

- a- Commissioner Burns noted that we are need of obtaining bids for Snow Removal services for 2017-2018. Secretary Krause will forward recent proposals and/or RFPs for both snow removal and lawn care. Our current snow removal contractor, Jeff Stangle, is no longer doing snow removal. We should secure by August 2017.
- b- The front door to the engine room at Station #2 is still giving problems
- c- Kot Electric fixed the lights in front of Station #1

## 2) Commissioner Van Apeldoorn:

- a- The floor polisher at Station #2 is broken. He proposed buying a new one or borrowing Station #1's machine.
- b- Regarding the Chief Show, Commissioner Van Apeldoorn would like to offer some suggestions for change going forward regarding the Hospitality Room. Commissioner Wickham suggests we go to the Town of Bethlehem Officers meeting to discuss.

#### 2) Commissioner Strock:

- was not present

### 3) Commissioner Ten Eyck:

- a- Inquiry was made as to whether or not Chief Asprion has set a time to get with Joe Farley to discuss the layout of the top 16 radio frequencies for the new radios
- b- Commissioner Ten Eyck made note that the companies are responsible for the hardware and the layout of the program is done by the Town of Bethlehem

#### **CHIEF'S NOTES:**

- a- The new Echo Policy and form are being revised in hopes of putting into place soon. The Board of Fire Commissioners is in support of this policy. Chief Asprion and Secretary Krause are finalizing the Echo Call form for reporting purposes.
- b- Chief Asprion made contact with Firefighter LaPlante's company as a potentially new Medical Services resource for firefighter physicals etc.
  - c- Regarding the recent firefighter gear purchase, only three items had to be sent back for alterations.
- d- Chief Asprion initiated a Chicken Barbecue Fundraiser via The Glenmont Abbey. It will be held at Station #2 on August 10<sup>th</sup> from 4pm-6pm. They will accept pre-orders, have a drive-thru and take-out. The Glenmont Abbey will match all proceeds and donate to the Selkirk Fire District.
  - e- The ATV Trailer is complete. The lettering for the ATV/Gator is yet to be completed.
  - f- The next Hose Testing will be on Thursday June 22<sup>nd</sup> and Friday, June 23<sup>rd</sup> at Station #2.
- g- Regarding the purchase of the new fire boat from Troy Fire Department, there is a hold up on paperwork from the City of Troy. We will have to obtain a title. Chief McMann, the Assistant Chief of the Troy Fire Department

has it at The Coeymans Marina being cleaned up. Chief Asprion is currently discussing the lettering with Rob Potter of Movin Ads and Signs, LLC.

h- Chief Asprion would like to declare our old fireboat, R-4, surplus

-i- Chief Asprion noted that the turnout for the 2017 Chief show was decent
